Regular Monthly Dividend Declaration

Toronto, Ontario – April 18, 2007 / CCN Matthews: Dividend 15 Split Corp. (“Dividend 15”) declares its regular monthly distribution of \$0.10 for each Class A share (\$1.20 annually) and \$0.04375 for each Preferred share (\$0.525 annually). Distributions are payable May 10, 2007 to shareholders on record as of April 30, 2007.

Since inception Class A shareholders have received a total of \$4.95 per share (including 5 special distributions totaling \$1.25 per share) and Preferred shareholders have received a total of \$1.64 per share inclusive of this distribution, for a combined total of \$6.59.
