Regular Monthly Dividend Declaration

Distributions are payable January 9, 2009 to shareholders on record as of December 31, 2008.

Since inception Class A shareholders have received a total of \$9.20 per share (including five special distributions of \$0.25 per share, one special distribution of \$0.50 per share and one special stock dividend of \$1.75 per share) and Preferred shareholders have received a total of \$2.51 per share inclusive of this distribution, for a combined total of \$11.71 per share.

Shares held within the portfolio are expected to range between 4-8% in weight but may vary at any time.
