Since inception Class A shareholders have received a total of \$10.60 per share (including five special distributions of \$0.25 per share, one special distribution of \$0.50 per share and one special stock dividend of \$1.75 per share) and Preferred shareholders have received a total of \$3.13 per share inclusive of this distribution, for a combined total of \$13.73 per share.
