Regular Monthly Dividend Declaration

Toronto, Ontario – October 18, 2006 / CCN Matthews: Dividend 15 Split Corp. (“Dividend 15”) declares its regular monthly distribution of \$0.10 for each Class A share (\$1.20 annually) and \$0.04375 for each Preferred share (\$0.525 annually). Distributions are payable November 10, 2006 to shareholders on record as of October 31, 2006.

Since inception Class A shareholders have received a total of \$4.10 per share (including 4 special distributions totaling \$1.00 per share) and Preferred shareholders have received a total of \$1.38 per share inclusive of this distribution, for a combined total of \$5.48.
