## **DIVIDEND 15 SPLIT CORP.**

### **Regular Monthly Dividend Declaration**

**Toronto, Ontario – October 20, 2008 / Marketwire:** Dividend 15 Split Corp. (“Dividend 15”) declares its regular monthly distribution of \$0.10 for each Class A share (\$1.20 annually) and \$0.04375 for each Preferred share (\$0.525 annually). Distributions are payable November 10, 2008 to shareholders on record as of October 31, 2008.

Since inception Class A shareholders have received a total of \$9.00 per share (including five special distributions of \$0.25 per share, one special distribution of \$0.50 per share and one special stock dividend of \$1.75 per share) and Preferred shareholders have received a total of \$2.43 per share inclusive of this distribution, for a combined total of \$11.43 per share.

Shares held within the portfolio are expected to range between 4-8% in weight but may vary at any time.
