Regular Monthly Dividend Declaration

Toronto, Ontario – April 18, 2008 / CCN Matthews: Dividend 15 Split Corp. II (“Dividend 15 II”) declares its regular monthly distribution of \$0.10 for each Class A share (\$1.20 annually) and \$0.04375 for each Preferred share (\$0.525 annually). Distributions are payable May 9, 2008 to shareholders on record as of April 30, 2008.

Since inception (November 16, 2006) Class A shareholders have received a total of \$1.70 per share and Preferred shareholders have received a total of \$0.76 per share inclusive of this distribution, for a combined total of \$2.46.
