Regular Monthly Dividend Declaration

Toronto, Ontario – August 20, 2007 / CCN Matthews: Dividend 15 Split Corp. II (“Dividend 15 II”) declares its regular monthly distribution of \$0.10 for each Class A share (\$1.20 annually) and \$0.04375 for each Preferred share (\$0.525 annually). Distributions are payable September 10, 2007 to shareholders on record as of August 31, 2007.

Since inception (Nov 16/06) Class A shareholders have received a total of \$0.90 per share and Preferred shareholders have received a total of \$0.41 per share inclusive of this distribution, for a combined total of \$1.31.
